Will preferential voting apply in the Council election?	Confirming that I have received advice from the VEC and preferential voting will still apply to the upcoming election for Greater Shepparton.	11/06/2024	
Confirming timeframe for initial Councillor training period is 4 months?	That is correct. The Local Government Amendment (Governance and Integrity) Bill 2024 received Royal Assent yesterday (Tuesday 25 June), which reduced the time period to complete mandatory training (from 6 months to 4 months).	26/06/2024	
It does look as though Fridays are mostly free during the Councillor Induction Program, is this likely to be the case?	We are trying to limit the induction program to a maximum of 4 days per week, but this won't always be possible. I can confirm that there will be a mandatory training delivered on Friday 15 November 2024. Where possible, we will try to record the mandatory sessions in case Councillor/s are unable to attend, but it will be more beneficial to attend on the day to enable question time etc.	26/06/2024

Campaign signage - when and where signs can be placed as part of campaigns?	We are currently updating a guideline document in relation to Electoral Signage which will be uploaded to the candidates web page following the 23 July Council Meeting (subject to adoption). In short – Council does not permit electoral signage to be placed on Council land / reserves / roads / property. This includes street furniture such as bus shelters, light poles, etc. They may be placed on private property with the consent of the property owner, and must meet the following requirements: • A sign with an advertisement area not exceeding 5 square metres publicising a local educational, cultural, political, religious, social or recreational event not held for commercial purposes. • Only one sign per candidate may be displayed on the land, it must not be an animated or internally-illuminated sign. • The electoral sign must not be displayed longer than 3 months or more than 14 days after the election (9 November 2024), whichever is sooner. • A sign publicising a local political event may include information about a candidate for an election.

Regulations regarding donations / funding for campaigns? For example, who can donate or how much?	In relation to campaign donations – there are some legislative requirements that apply (refer Section 306 of the Local Government Act for full details), however nothing that limits who can make the donation or how much. The key points to be aware of, are that: • Candidates must submit a campaign donation return to the CEO within 40 days of election day (Election Campaign Donation Return Form, Candidate Kit Page 15) • The return must disclose the name of donor, gifts received within the donation period and the amount / value, where it is equal to or exceeds the gift disclosure threshold (\$500) Note – any campaign donations of \$500 or more (disclosable gift) will constitute a conflict of interest between that Councillor (if elected) and the individual / business who provided the campaign donation. The Act goes into a bit more detail but they are hopefully the key points of interest. This topic will likely be covered at the information session being hosted by the Victorian Electoral Commission on 5 September (6.30pm at Election Office, 132 Welsford Street Shepparton).	15/07/2024
